

CANCELLATION TERMS

- 1) Registration Cancellation before and on April 29: free of charge.
- 2) Registration Cancellation on April 30 and later: no refund.
- 3) Networking Events Cancellation before and on April 29: free of charge.
- 4) Networking Events Cancellation on April 30 and later: no refund.
- 5) All refunds will be processed after the EANS2019 Congress.
- 6) Administration Fee for name change/invoice address change/further changes is EUR 20 incl VAT.
- 7) Any loss of name badge will be charged with EUR 100 incl VAT.
- 8) The Organiser retains the right for any changes deemed necessary.

PAYMENT TERMS

- 1) Booked registration fees are binding and must be paid in advance.
- 2) Payments can be done via bank transfer and credit card. Any bank charges will be charged to the payer.
- 3) Registration fees depend on the date your payment is received and will be adjusted accordingly, if the payment is not received by the relevant deadline.

Thereafter, the details will be destroyed in a secure manner.
